

# Stay! Pet B&B Pet Lodging Contract

Pet's name

1. \_\_\_\_\_ I release Stay! Pet B&B and Jules Veterinary Center of any liability arising from my pet's stay at Stay! Pet B&B.
2. \_\_\_\_\_ I fully accept all reasonable risks of illness or injury that may be incurred during normal lodging activity. Such risks include, but are not limited to: cuts, scrapes, and other minor injuries resulting from play; and possible contagious illnesses such as upper respiratory infections and Kennel Cough.
3. \_\_\_\_\_ Stay! Pet B&B agrees to exercise due and reasonable care in the handling of animals, and in keeping the facility properly enclosed and sanitary. All animals are cared for by Stay! Pet B&B and Jules Veterinary staff without liability on Stay! Pet B&B and Jules Veterinary Center's part for loss or damage from disease, theft, fire, death, escape, injury, or harm to persons, other pets, property, or for other unavoidable causes, due care and diligence having been exercised.
4. \_\_\_\_\_ **DOGS ONLY** I understand that I am solely responsible for any harm caused by my dog, while my dog is attending Stay! Pet B&B, provided reasonable care and precautions are followed by Stay! Pet B&B staff.
  - 4a. My dog **can only be exercised alone** without any other dogs in the yard. **Yes** or **No** \_\_\_\_\_
  - 4b. My dog **must be** on a leash at all times while exercising **Yes** or **No** \_\_\_\_\_

5. \_\_\_\_\_ I shall compensate Stay! Pet B&B and/or Jules Veterinary Center against any claims made against the company, or any losses or damage of any kind suffered by Stay! Pet B&B and Jules Veterinary Center as a result of my failure to inform Stay! Pet B&B and Jules Veterinary Center of any pre-existing condition(s) my pet may have (including, but not limited to an illness or known aggression problem).
6. \_\_\_\_\_ I understand that if my **dog** has not been spayed/neutered, she/he will have to be exercised alone; additional private exercise charges are my responsibility. I also understand females are at risk of becoming pregnant, and will not hold Stay! Pet B&B responsible or liable if a pregnancy occurs.
7. \_\_\_\_\_ I agree to take precautions against contagious illness exposure by providing current vaccine records. If my pet's vaccines (Rabies, Da2pp, and Bordetella)(PRC) are not current Stay! Pet B&B and Jules Veterinary Center has the right to vaccinate my pet during the stay, all costs pertaining to updating vaccines will be paid at the time of release.
8. \_\_\_\_\_ I understand that in the event of injury, Stay! Pet B&B and Jules Veterinary Center's staff will notify me immediately. If the injury is serious, or requires medical attention, my pet may have restricted exercise, and medical fees incurred will be my responsibility at the time of release.
9. \_\_\_\_\_ I understand and agree that should my pet become ill or in need of medical attention, Stay! Pet B&B and Jules Veterinary Center will first try to contact me, and then my emergency contact references provided. If unable to reach me in an emergency situation, Stay! Pet B&B and Jules Veterinary Center's staff will comply with what I have agreed to on my pet's interview form.
10. \_\_\_\_\_ I understand that my pet will only be released to the owner(s) on file, unless prior arrangements have been made, in writing, with a Stay! Pet B&B staff member.
11. \_\_\_\_\_ I understand that my pet(s) will not be released without full payment at the time of pick up.
